Effect of Elephant grass (*Pennisetum purpureum*) ensiled with different proportions of *Dolichos lablab* (Lablab purpureus) on intake, digestibility and growth performance of Horro sheep

#### **Abstract**

The study was conducted at Bako Agricultural Research Center with the aim to evaluate the effect of Elephant grass ensiled with different proportions of Dolichos lablab on intake, digestibility and body weight gain of Horro sheep. Elephant grass and Dolichos lablab were harvested after eight weeks of regrowth and 50% blooming stage, respectively. Forages were chopped, weighed separately and mixed with 3% molasses before ensiling in a pit. A total of twenty intact male yearling Horro sheep were stratified into four groups based on initial body weight in a Randomized Complete Block Design and randomly assigned to the dietary treatments. Dietary treatments were Elephant grass ensiled alone, with 10, 20 and 30% of Dolichos lablab and designated as T1, T2, T3 and T4, respectively. Lambs in all treatments were supplemented with wheat bran at 1.5% body weight. The study comprised 90 days of feeding trial followed by 7 days of digestibility trial. The dry matter content of the silage increased from 30.14 to 35.34 and crude protein content from 8.75 to 12.38% from T1 to T4. However, it contained 15.15, 14.30 and 50.70% NDF, ADF and ADL concentrations, respectively. The total DM intake of lambs fed T4 diets was greater by 19.53, 7.83 and 3.56%, whereas the total CP intake was higher by 31.15%, 17.36%, and 9.66% than T1, T2 and T3, respectively. Higher ADL and lower ADF intake were observed for lambs fed T1 diet. The DM Digestibility of lambs fed T4 diets were increased by 17.59, 10.09 and 6.18% than those on T1, T2 and T3 diets, respectively. Lambs fed T4 diet had higher digestibility of CP and NDF than those fed T3, T2 and T1 with comparable values of NDF obtained for T4 and T3. The lowest ADF digestibility was recorded for lambs fed T1 diet with similar values among other groups. Lambs fed T4 diet had higher final body weight (28.04 kg) compared to T2 (26.08 kg) and T1 (23.52 kg) and higher daily gain of 43.55, 59.55 and 73.11 g/day for T1, T2 and T3, respectively. Higher value of FCE was obtained from lambs fed T4 diet followed by T3 > T2 > T1 in that order. Therefore, addition of 20-30% Dolichos lablab in Elephant grass silage enhanced its nutritive value, thereby increasing the nutrient intake and digestibility for better growth of Horro sheep.

#### Introduction

Like other developing countries in sub Saharan Africa, small ruminant production is a major component of the livestock sector in Ethiopia. According to Central Statistics Agency (CSA, 2018) report, the total small ruminant

population in Ethiopia is estimated to be 64.04 million, out of which 31.3 million are sheep. At smallholder level, sheep are the major source of food security, serving a diverse functions including cash income, savings, cash for fertilizer purchase and sociocultural

functions (Solomon *et al.*, 2013). However, the productivity of sheep per head is low mainly because of inadequate year round nutrition, both in terms of quantity and quality, unimproved genetic potential and due to prevalence of diseases and parasites (Markos *et al.*, 2006).

Presently, most natural pasturelands are under intensive crop production due to increasing human population pressure. The remaining land is heavily grazed and cannot meet the nutritional requirement of livestock, resulting in reduced growth rate, low production, poor fertility and high mortality particularly in the dry season (Solomon, 2004). The aftermath of grazing and crop residue accounts for 60 to 70% of available basal diet in the highlands of Ethiopia. Such feeds are inherently low in nutritive value such as protein, digestible energy and minerals, which may result in suboptimal rumen fermentation and lowered animal performance (Malede and Tekele, 2014). Thus, animals could not realize their genetic potential within the growth period for the breed

To solve this problem, there are options like supplementing animals with agro-industrial by-products such as different oil seed cakes and brans from edible oil and flour processing industries. However, they are expensive and not readily available. The other option could be through cultivation of high-quality forages with high yielding ability that are adapted to biotic and abiotic environmental stresses (Muia et al., 2001: Tessema et al., 2010). Improved pasture crops have many advantages such as providing quality feed and improving soil fertility. The cost incurred for perennial pasture production is high only during the establishment year (Jørgensen et al., 2010) but declined thereafter which could serve for the way forward in feed resources improvement strategies in Ethiopia. Amongst the promising forage species promoted in Ethiopia, Elephant grass could play an important role in providing a significant amount of high-quality forage to the livestock industry (Ndikumana, 1996; Tessema, 2005) both under the smallholder farmer and intensive livestock production systems with appropriate management practices (Alemayehu, 2004).

The use of improved forage and tree legumes as supplementary options for livestock have been investigated in Ethiopia and elsewhere in Africa (Solomon et al., 2004; Ajebu et al., 2008 and Adegun, 2014). Improved forages could be fed to the animals by direct grazing, cut and carry, or stored and conserved as hay or silage. The potential of legumes for grazing is limited due to their susceptibility to trampling and the preferential grazing by livestock (Phelan et al., 2015). Additionally, fresh feeding of legumes is limited due to the seasonality of rain which reduces the independence from protein-rich feedstuffs during the dry season. Moreover, legume feeding as hay is restricted by high dry-matter losses which occurs during drying, transport and storage. Furthermore, the practical implications of season and plant physiology may prevent timely harvest/drying at the optimal time for hay making (Titterton and Bareeba, 1999).

The limitations due to leaf shattering, harvest timing and availability in the dry season are minimized when forages are conserved as silage, making this probably the most suitable option to feed tropical legumes to ruminants. The development of small-scale intensive systems and the rising costs of concentrate feeds, made the conservation of forage crops an integral part of livestock production (Mapiye et al., 2007). Conserving high quality forages reduces the need to purchase concentrates for use in ruminant rations. Surplus and cultivated quality forages should be conserved during the wet season for use during the dry season. To this effect, silagemaking is a common means of preserving surplus forage which could be fed to livestock during periods of scarcity. By conserving excess forage produced during the wet season to silage, the low production and productivity of livestock during the dry season due to scarcity of forage can be ameliorated (Wong, Conservation of cereals/grasses produce silages of high energy but low protein concentration (Mhere et al., 2002). On the other hand, legumes alone do not ensile well owing to their high moisture content and buffering capacity, resulting in high effluent losses and unstable silage of high pH (Pahlow et al., 2002). Incorporation of legumes in cereal silage increases protein concentration, improves silage intake and its nutritional quality thereby enhancing ruminant animal performance (Ngongoni et al., 2008).

A number of Elephant grass and Dolichos lablab varieties have been shown to produce high dry matter yield and adapted to a wide range of agro ecologies across the country. However, they contribute little to the much needed improvement of livestock production because data regarding the conservation of mixed grass-legume forages as silage are scarce. Similarly, feeding of silage in general and grass-legume mixed silage in particular for sheep as a basal diet is not practiced in the area. Therefore, alternative study resources including conserved grass-legume mixed silage and Elephant grass ensiled alone or with different proportions of Dolichos lablab have not yet been investigated and exploited.

Thus, the study was undertaken with the objective to evaluate the effect of Elephant grass ensiled with different proportions of *Dolichos lablab* on feed intake, nutrient digestibility and growth performance of Horro sheep.

# Materials and Methods Description of the study area

The experiment was conducted at Bako Agricultural Research Center which is located in Oromia Regional State, West Shoa Zone at about 257 km from the capital city Addis Ababa on the way to Nekemte town. The center is located at 8 km from Bako town. The altitude of the research center is 1650 m above sea level and lies on Latitude 09°6'N and Longitude 37°09'E. The area has a warm subhumid climate with annual mean minimum and maximum temperatures of 13°C and 29.9°C, respectively. Mean monthly minimum and maximum temperatures are about 10.4°C and 33.6°C, respectively, with an average monthly temperature of 21°C. The daily mean minimum and maximum temperatures are 9.4°C and 31.3°C, respectively. The area has a unimodal type of rainfall and receives annual rainfall of 1431 mm mainly from May to September with maximum precipitation between the months of June and August. Sixty percent of the soil is Vertisol and clay-loam in texture (Wakene, 2001).

# Forage production and preservation

Pre-existing Elephant grass accession (ILRI 14984) at Bako Agricultural Research Center (BARC) forage production station was cut at about 50 cm height above the ground in order to promote re-growth for later silage making. In other fields, *Dolichos lablab* seeds were sown at recommended rate of 20 kg/ha under rain fed after ploughing and harrowing, then hand weeded and safeguarded from different wild animals. The removing (cutting) of Elephant grass was mainly to match its appropriate harvesting time with *Dolichos lablab* during silage making.

Elephant grass was harvested after eight weeks of re-growth at a height of 1m, while the complete foliage of *Dolichos lablab* was harvested at 50% blooming stage. The

Elephant grass and Dolichos lablab were separately chopped in to smaller pieces using a tractor driven chopper before ensiling to make it easy to compact silage and remove air from the pit. Before ensiling, plant materials were mixed according to treatment combinations. To improve fermentation quality of ensiling materials 3% molasses was uniformly to all treatments over the chopped fodders and thoroughly mixed. For the ease of application, the molasses was diluted with water at a ratio of 3:1 water to molasses before use. The chopped and mixed fodder ready for ensiling were preserved in separate pit silos lined with polythene sheets. It was compacted by trampling with feet, covered with polythene sheets and soil heaped on the pit to maintain anaerobic conditions during storage. The silages was opened after 45 days and used in a feeding trial to evaluate the intake, digestibility and performance of sheep fed Elephant grass and Dolichos lablab mixed silage ad libitum.

**Experimental animals and management** 

Before the commencement of actual experiment the experimental house, pens, feeding and watering trough were properly cleaned and disinfected. A total of twenty intact male yearling Horro sheep with initial

body weight of  $19.47\pm1.76$  kg (mean  $\pm$  SD) used for this experiment were bought from local markets. Age of the animals were determined by their dentition and information obtained from owners. The experimental animals were ear-tagged for identification, quarantined for fifteen days and vaccinated against common infectious diseases in the area. During the quarantine period, animals were de-wormed against internal parasites using anti helminthes (Albendazole) and sprayed with accaricide (diazzinon 60%) against external parasites. Thereafter, the experimental animals were assigned into different treatments after which the animals were randomly put in to separate well ventilated pens having a feed trough and water was freely provided.

# **Experimental design and treatments**

A Randomized Complete Block Design (RCBD) was used. The experimental animals were grouped into five blocks of four animals based on their initial body weight. Animals in a block were assigned to one of the four treatments and uniformly supplemented with wheat bran at the rate of 1.5% of body weight across all the treatments. The arrangement of dietary treatments were as follows;

T1: Elephant grass ensiled alone

T2: Elephant grass ensiled with 10% Dolichos lablab

T3: Elephant grass ensiled with 20% Dolichos lablab

T4: Elephant grass ensiled with 30% Dolichos lablab

# Feeding trial

The feeding trial was conducted for 90 days following an acclimatization period of 14 days. The amount of feeds offered and the corresponding refusals were weighed and recorded for each experimental animal to determine feed intake. Representative samples of feeds offered and refused for each animal was collected and pooled per treatment and

dried in an oven at 65°C for 72 hours. All the experimental animals had free access to clean water and mineralized salt block. Mean daily dry matter and nutrient intake were determined as the difference of offered and that of refused. The daily DM intake expressed as percent of body weight and metabolic body weight of animals was calculated by employing the following formula of (McDonald *et al.* 2002):

# **Digestibility trial**

Following the feeding trial, the digestibility trial was conducted with the same animals used in the feeding trial. All experimental animals were harnessed with fecal collection bags for three days of adaptation period before the resumption of actual collection of faeces for seven days. Daily total fecal output of each animal was weighed individually and recorded daily each morning before offering feed. The feces were then mixed thoroughly and 20% of the daily fecal output was taken and bulked across the experimental period to form a weekly fecal composite sample for each animal and kept in a deep freezer at -20°C. On

the last day of the collection period, the composite fecal samples were thaw and thoroughly mixed and a representative subsample was taken.

Samples of feed offered and feed refused were also collected every day and sub-sampled at the end of the experiment. The digestibility of DM and nutrients were determined as the difference between nutrients intake and that recovered in feces expressed as a proportion of nutrient intake. The total amounts of apparent nutrient digestibility were calculated using the following equation (Ranjihan, 2001).

The estimated metabolizable energy intake of sheep from treatment feeds were calculated using the formula (McDonald *et al.*, 2002): ME (MJ/Kg DM) = 0.016 X *IV*DOMD, Where *IV*DOMD = is gram Digestible Organic Matter per kilogram Dry Matter.

# **Body weight change and feed conversion efficiency**

The initial body weight of each animal was taken at the beginning of the trial and lambs were weighed at 15 days interval during the 90 days of feeding trial to determine body weight change during the experimental period. All animals were weighed after they are denied

access to feed by removing feed not consumed until 6:00 pm on the day before the weighing day using spring balance. Average daily body weight gain (ADG) and Feed conversion efficiency (FCE) were calculated according to the formula of Gulten *et al.* (2000) and Brown *et al.* (2001).

Where: ADG is Average Daily Body Weight Gain and FCE is Feed Conversion Efficiency.

#### Chemical analysis

Partially dried fecal samples were ground to pass through a 1 mm sieve screen using Wiley mill and stored airtight plastic bags pending chemical analysis. The samples were taken to Holeta Agricultural Research Center, Animal Nutrition Laboratory for chemical analysis. The nitrogen (N), Dry matter (DM), Organic matter (OM) and ash contents were analyzed according to AOAC (1990). The crude protein (CP) content was calculated by multiplying N content with a factor of 6.25. Neutral detergent fibers (NDF), acid detergent fiber (ADF) and acid detergent lignin (ADL) were analyzed based on the method of Van Soest *et al.* (1994).

# Statistical data analysis

The data generated during the experimental period were subjected to analysis of variance (ANOVA) following the General Linear Model (GLM) procedure of SAS version 9.0 (SAS, 2002). Significant means (P<0.05) were separated by Duncan's multiple range tests. The model used for data analysis was:

Correlation analysis was employed to determine the relationship between nutrient intake and its corresponding digestibility and live weight change.

# Results and Discussion Chemical Composition of Experimental Feeds

The nutrient composition of the feeds used in the study are presented in Table 1. The dry matter, crude protein and digestible organic matter in dry matter content of the silage increased as the proportion of *Dolichos lablab* in the mixture increased. On the contrary, Ash, NDF, ADF and ADL of the ensiled mixtures reduced with increasing inclusion level of Dolichos lablab, showing that addition of Dolichos lablab was effective in improving nutritional values of the Elephant grass silage. However, organic matter of the experimental feed was almost similar. T4 diet contained 14.7 and 29.32% more DM and CP, respectively than T1. However, it contained 15.15, 14.30 and 50.70% less NDF, ADF and ADL concentrations, respectively. The CP content of silage used in the present study ranged from 8.75 to 12.38 % which was above the 7% CP required for microbial protein synthesis in the rumen in order to meet the maintenance requirement of ruminants (Van Soest et al., 1994). The result obtained in the present study was comparable with Gachuiri et al. (2003) and Conteras-Govea et al. (2009) that reported the CP content of the Elephant grass silage increased from 9.7% to 11.2% with the addition of 20% Dolichos lablab. Furthermore, silage with a high level of CP is beneficial because it allows for increased proteolysis. which results in a buffering effect that hinders the reduction of the pH to levels that are optimum for fermentation (Napasirth et al., 2015).

The CP content of wheat bran was higher than results of 16.1, 14.48, 13 and 15.98% reported by Wondwesen (2010); Radia *et al.* (2013); Teklu (2016) and Abuye *et al.* (2018) respectively. However, it was comparable with values of 17.19, 16.9, 17.77, 18 and 17.46% reported by Getnet (1998); Yenesew *et al.* (2013); Hunegnaw (2015); Mekonnen *et al.* (2016) and Firaol (2017). But it was relatively lower than the CP value of 20.10 and 23.08%

reported by Simret (2005) and Awet and Solomon (2009). The wheat feed nutrient composition varies depending on variety of wheat being milled and the processing method used (McDonald et al. 2002). Regarding feed refusal, the CP and DOMD contents were reduced and that of NDF, ADF and ADL increased with the increasing inclusion levels of *Dolichos lablab* in the mixed silage as compared to the feed offered, indicating selectivity by animals for nutritious parts of the feed.

# Dry matter and nutrient intake

The levels of *Dolichos lablab* inclusion in Elephant grass silage influenced the intake of dry matter, crude protein, Organic Matter and Acid detergent lignin (P<0.001), Metabolizable energy (P<0.01), and acid detergent fiber (P<0.05) without influencing the intake of neutral detergent fiber (Table 2).

The total DM and silage dry matter intake was significantly higher (P<0.001) for lambs fed T4 diet than those on T1 and T2 with no statistical difference (P>0.05) between lambs fed in T3 and T4 diets. The total DM intake of the present study showed that lambs fed T4 diets were greater by 19.53, 7.83 and 3.56% than those on T1. T2 and T3 diets. respectively. The difference could attributed to the high digestible protein content of the T4 diet compared to other dietary treatments, which might have enhanced the efficiency of rumen microorganisms that increased fiber degradability and digestibility thereby, improving feed intake (McDonald et al., 2002). Because all the experimental lambs consumed wheat bran based on their body weight, total DM intake showed the same pattern as silage DM intake.

The total DM intake obtained in the study which ranged from 768.4 to 954.9 g/day was comparable with the total DM intake (740 to 979.3 g/day) reported by Mekonnen *et al.* 

(2016) for the same sheep breed fed Cynodon dactylon alone or supplemented with Cajanus cajan, Lablab purpureus or their mixture. But, slightly higher than the total dry matter intake values (693.0 to 847 g/day, 680.94 to 783.33 g/day and 779.94 to 893.9 g/day) reported by Assefu (2012), Firaol (2017) and Abuye et al. (2018), respectively. Inclusion of legumes in Elephant grass silage based diets has previously been shown to increase dry matter intake (Abdulrazak et al., 1996), which has been attributed to improved palatability and digestibility. This observation has also been shown for wheat-pea silage fed to sheep and cattle (Adesogan et al., 2002) and for maize stover-Leucaena diversifolia fed to sheep (Hindrichsen et al., 2002).

The mean feed intake as a proportion of percent body weight and per unit metabolic body weight revealed significant difference (P≤0.001) among dietary treatments. Lambs fed T4, T3 and T2 diets (P>0.05) had similar performance on %BW basis and were significantly higher than, those on T1 diet. Whereas, significant (P<0.001) difference in per unit metabolic body weight basis was observed for lambs fed T4 diet followed by T3 as compared to T1 and T2 groups. The total DM intake on %BW basis of the present study was within the range of 2 to 6% recommended by the Agricultural Research Council (ARC) (1980) and 2 to 4% suggested by Susan (2003). Similarly, the DM intake per unit metabolic  $BW^{0.75}$  (75.97 and 89.62 g/kg) obtained in this study was comparable with the findings of Birhanu et al. (2013) and Jalel (2013) who reported ranges of 75.02 to 86.66 g/kg for Black Ogaden sheep and 76.2 to 85.9 g/kg for Horro sheep. The DM intake on percent BW and per unit metabolic body weight basis recorded in this study were slightly higher than those of Mekonnen et al. (2016) and Abuye et al. (2018) who reported 3.2-3.5% and 70.3-79.2 g/kg and 3.45-3.81% and 75.23-81.69 g/kg for the same sheep breed, respectively.

The observed variations among the studies emanated from the differences in the quality of the feeds used, animal factors (age and physiological status of the animals), rumen fill, rate of passage of articulate matter and digestibility of experimental feeds used.

The total organic matter intake was significantly (P<0.001) higher for lambs fed T4 diets than those fed T2 and T1, but, similar (P>0.05) with those in T3 group, which followed the same trend for DM intake as it is the reflection of total DM intake. Increased OM intake (P<0.001) when lambs were fed silage consisting 30% inclusion level of Dolichos lablab might be due to the increased total DM intake and CP intake. The total CP intake was significantly higher (P<0.001) for sheep fed diet in T4 than T1, T2 and T3. The values of the CP intake in this study which ranged from 94.8 to 137.7 g/day were comparable with 93.9 to 145.1 and 103 to 158 g/day reported by Assefu (2012) and Mekonnen et al. (2016), respectively. However, the results were higher than the values ranges (90.0 to 108.9 and 81.7 to 116.36 g/day) than those reported by Yeshambel et al. (2012) and Abuye et al. (2018), respectively. According to Osuji et al. (1995), leguminous fodder trees increase protein supply to the host animal by creating a favorable rumen environment resulting in enhanced fermentation of the basal roughage and thus increased microbial protein synthesis. This implies the presence of direct relationship between CP content of feeds and feed intake (Tesfaye, 2007).

Higher (P<0.001) acid detergent lignin intake was observed for lambs fed T1 diet as compared to other dietary treatments, but no significant difference (P>0.05) was observed between lambs fed T2, T3 and T4 diets. Total ADF intake was lower (P<0.05) for lambs fed T1diet as compared to those in other groups. This might be due to the amount of fiber

fractions that existed in the feed which might have increased with increasing amount of total Dry Matter Intake (DMI). Ash intake was highest (P<0.05) for T1 followed by T4<T3<T2 in that order. In this study, NDF intake was not affected with increasing inclusion level of Dolichos lablab in the Elephant grass silage. According to Lonsdale (1989), feeds that have < 9, 9 - 12 and > 12 MJ ME/kg DM are classified as low, medium and high energy sources, respectively. The highest ME intake (9.99 MJ/day) and (9.94 MJ/day) obtained for T4 and T3 were above the estimated daily ME (8.5 MJ/day) requirement of lambs weighing 30 kg and daily gain of 100 g/day (ARC 1980). In this study the metabolizable energy intake was highest for lambs fed T4 diet compared to T1 and T2 that were statistically similar with those on T3 diet. This can be attributed to the difference in OM digestibility. Thus, the advantage of *Dolichos* lablab inclusion in Elephant grass silage is the increased DM intake, which ensured higher digestible nutrient uptake.

# Apparent nutrient digestibility

Apparent nutrient digestibility of Horro sheep fed Elephant grass ensiled with different proportions of *Dolichos lablab* is presented in Table 3.

Dry matter and organic matter digestibility of the diets varied significantly (P<0.001) across the treatments with higher digestibility for T4 as compared to T1 diet. Apparent DM and OM digestibility were significantly higher (P<0.001) for lambs fed T4 diet as compared to those fed T2 and T1 diets with no significant difference (P>0.05) from lambs fed T3 diet.

The improved DM and OM digestibility for lambs fed T3 and T4 diets might be associated with higher CP intake that have created a better environment by providing more N for rumen microorganisms. According to Bonsi *et al.* (1996) lower CP content of feeds affect microbial growth and fermentation in the rumen and consequently digestibility of DM

and nutrients. In support of the present finding, et al. (2009)noted Lapenga supplementation of Mubende goats fed Elephant grass with different protein and energy sources increased DM and OM digestibility. The DM Digestibility of the current study revealed that lambs fed diets in T4 were increased by 17.59, 10.09 and 6.18% than lambs in T1, T2 and T3 diets, respectively. Similarly, Awet and Solomon (2009) reported significant variation in apparent digestibility of DM and OM for Afar sheep fed urea treated teff straw supplemented with graded level of wheat bran. Getahun (2014) also reported that lambs supplemented with 300 g/day of leucenea to untreated wheat straw significantly increased the apparent digestibility coefficients of DM and OM compared to the sole untreated straw. Olorunnisomo (2011) pointed out that the DM digestibility (%) of red Sokoto goats fed Elephant grass ensiled alone increased from 54.67 to 68% with the addition of 50% cassava peel in the mixture. The DM digestibility was slightly greater than the range (57±1.4 to 60±1.3%) reported by Gachuiri (2003) for Elephant grass ensiled with 20% of Dolichos lablab.

Significant differences (P < 0.001)observed in digestibility of CP among dietary treatments. Lambs fed T4 diet had higher CP digestibility than those on T3, T2 and T1 with no significant difference (P>0.05) between T2 and T3 with the lowest digestibility coefficient recorded for lambs fed T1 diet. Banamana et al. (1990) reported that increasing CP in the diet increased the digestibility of OM, ADF and CP. Mulligan et al. (2001) also reported that increasing dietary CP content increased the digestibility of low quality hay. In this study, increased CP intake with increasing levels of *Dolichos lablab* in the silage mixture was followed with increase in DM, OM, and CP digestibility. In agreement with the present study, significantly different apparent

digestibility of CP was reported by Berhanu *et al.* (2014) in Washera sheep. Firisa *et al.* (2013) also reported significantly improved CP digestibility in Horro lambs supplemented with graded levels of *V. amygdalina* leaves and sorghum grain mixture. Furthermore, Abuye *et al.* (2018) reported that digestibility of CP for sheep fed basal diets of natural grass hay were improved when supplemented with Gebisa-17 and Beresa-55 cultivars of *L. purpureus* and concentrate mixture.

differences (P < 0.01)Significant observed in the digestibility of NDF among the dietary treatments. The highest digestibility of NDF was recorded in T4 followed by T3>T2>T1 in that order with almost comparable values obtained in T4 and T3. Apparent digestibility of **ADF** significantly different (P < 0.05)among treatments with the lowest ADF digestibility recorded for lambs fed T1 diet and similar values among other groups. Olorunnisomo (2011) also reported significant (P<0.05) improvement in NDF and ADF digestibility with the increasing inclusion level of cassava peel in Elephant grass silage.

# **Growth Performance of Horro Sheep**

Mean initial body weight, Final body weight, body weight change and average daily body weight gains among dietary treatments are presented in Table 4. The mean initial body weights of lambs assigned to dietary treatments were not significantly different (P>0.05) in all groups. Significant differences were recorded in final body weight between dietary treatments.

The highest (P<0.001) Final Body Weight (FBW) was observed for lambs fed T4 diet which was statistically similar (P>0.05) with T3. Lambs fed diets in T4 had final body weight greater by 16.08, 10.98 and 6.99% than those on T1, T2 and T3 diets, respectively. The growth rate of lambs fed T4 was higher as compared to those fed other dietary treatments.

Also their daily gain was more by 55.66, 39.37 and 25.56% than T1, T2 and T3 groups, respectively. Similar trend was also observed among all treatments in BW change attributes. The lower body weight gain for lambs fed Elephant grass ensiled alone could be attributed to the low CP and ME intake resulting in poor supply of nutrients. Ensminger (2002) also showed that low energy intake that results from either feed restriction or low ration component digestibility prevents sheep from meeting their requirements and attaining their genetic potential.

In this study, an increasing trend was observed in body weight change from T1 to T4 (Figure 1) and animals fedT1 diet were lighter by 4.92 kg than those fed T4. This appeared to be consistent with difference in nutrient digestibility like, DM, CP and OM (Table 3) that might have resulted in difference in nutrient intake available for absorption and metabolism. Increased live weight gain of Horro sheep supplemented with different levels of concentrate on a basal diet of barley (mosnoo) straw was reported (Gemeda et al. 2003). The mean values of the final body weight (FBW) in this study (23.52-28.04 kg) were comparable with 23.2-28.6 and 23.82-30.32 kg reported by Mekonnen et al. (2016) for Horro and Firaol (2017) for Arsi-Bale sheep, respectively. However, FBW obtained were slightly higher than those reported by Assefu (2012) and Abuye et al. (2018) for the same breed. Takele et al. (2004) reported that supplementation with higher levels of wilted Leucaena pallida leaf 410 g/h/d and 150 g/h/d ground maize or maize-noug at a level of 300 g/h/d had improved final body weight, total weight gain and average daily gain.

The values of ADG observed for all group of lambs fed Elephant grass silage containing different proportion of *Dolichos lablab* in the current study were considerably higher than the highest value (36.7 g/day) of ADG

achieved at higher level of lowland bamboo leaf hay inclusion in Washera lambs fed mixtures of lowland bamboo leaf hay and natural pasture grass hay at different proportion (Yeshambel *et al.*, 2012) and the highest ADG value 47.2g/day reported by Getahun (2014) for the Ethiopian highland sheep supplemented with 300g/day leucaena on urea treated and untreated straw. Similarly, lower ADG values ranged from 33.3 to 58.7g/day for Horro lambs and 40.2 to 48.7g/day for Washera lambs were reported by Assefu (2012) for lambs fed rations containing different roughage to concentrate ratios.

Comparative results to present study ADG values of 27.8 to 87.4 g/day was reported by Mokennen et al. (2016) for the same breed fed Cynodon dactylon alone or supplemented with Cajanus cajan, Lablab purpureus or their mixture and rations containing different roughage to concentrate. Similarly, comparable ADG values (32.33 to 85.11 g/day) were reported by Malisetty et al. (2013) for Nellore ram lambs fed maize silage supplemented with concentrate and legume hay. The highest ADG value 98.22 g/d observed in lambs fed T4 diet in this tudy was within the range (69.1 to 104.1g/day and 49.33 to 116.22 g/day) reported by Belete et al. (2013) and Firaol (2017), respectively. However, the results were slightly higher than that (29.33 to 75.56 g/day) reported by Abuye et al. (2018) for Horro sheep fed natural grass hay and supplemented with Gebisa-17 and Beresa-55 cultivars of Lablab purpureus and concentrate mixture. The positive ADG observed for lambs fed Elephant grass silage alone was due to the supplementation with wheat bran.

In the present study, higher value in FCE was obtained by lambs in T4 (0.1) followed by T3 (0.08) > T2 (0.07) > T1 (0.06) showing that lambs in T4 utilized diet better than other diets. The reduction in FCE for lambs fed T1 diet

was probably the result of low protein and energy intake and high fiber content of the diet that might have caused the net efficiency of use of metabolizable energy to be depressed slightly. Lambs fed legumes have more efficient dietary protein utilization and grow faster than lambs fed grass, in part due to a more rapid rate of digestion (Howes, 2015).

# Correlation among intake, digestibility and body weight gain

Correlation nutrient between intake, digestibility and body weight gain parameters investigated on Horro lambs fed Elephant grass ensiled with different proportion of Dolichos lablab are presented in Table 5. Total DM intake was strongly and positively (P<0.001) correlated with CP intake, digestible dry matter, digestible crude protein and average daily body weight gain. This indicates that with increasing DMI, there was increasing BW gain as result a positive association was observed between these parameters. DMI, Digestible Dry Matter (DDM), DCP and ADG were strongly (P<0.001) and positively associated with CPI. In consistent with present study Tewdros (2011) reported that CP intake was positively and significantly correlated with Crude Protein Digestible (CPD) and ADG. Similarly, Mekonnen (2017) reported that CP intake for Horro sheep fed Cynodon dactylon hay alone or supplemented with Cajanus cajan, Lablab purpureus or their mixture is strongly and positively (P<0.001) associated with DMD, CPD and ADG.

#### Conclusion

It is concluded that mixing *Dolichos lablab* with Elephant grass had beneficial effects on silage properties, intake and digestibility of the nutrients. The addition of 20 to 30% *Dolichos lablab* in Elephant grass silage enhanced the nutritive value of the silage thereby, increasing the nutrient intake and digestibility for better growth of Horro sheep.

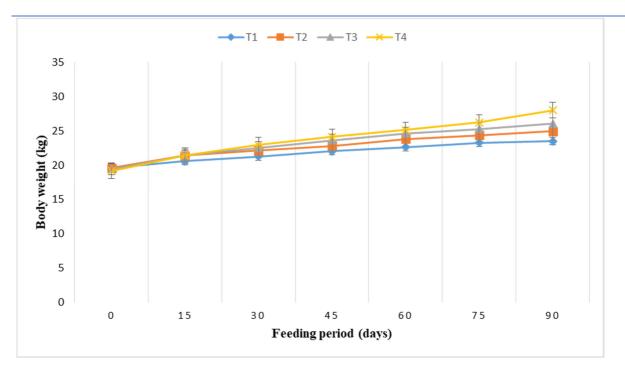
